The legal and contractual liability of a forwarder and carrier is covered in accordance with the German legal regulations, particularly the §§ 453 pp. HGB, as well as the German Forwarders Standard Terms and Conditions (ADSp) in the context of the above-mentioned insurance policy.

To the extent that the forwarder or carrier is liable, his liability is subject to the following maximum limits for each case of damage that means per each claimant and per each transportation-contract:
